WARNING

Under Nebraska & Iowa Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to this act.

Waiver: As a condition to participate in this event Kelli Paulson Crist, Dallas Crist and Jon Crannell, its officers, employees, members, agents, and representatives are hereby released from all claims, demands, or cause of action of any kind or nature whatsoever, whether now existing or hereafter accrue, on account of any damage, cost or expense (1) as a result of any bodily injury or any injury, loss or damage to any persons, (2) The risk of such damage, cost or expenses which may occur by reason foregoing is hereby assumed and accepted. This waiver is binding on the undersigned as well as all other person(s) associated with the participation of person(s) or animals(s) described herein in this event, and the undersigned indemnifies Kelli Paulson Crist, Dallas Crist and Jon Crannell from all claims, demands or causes of action based on any of the foregoing.

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, owner, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including, but not limited to, broken bones, head injuries, trauma, pain, suffering, or death (collectively "Harm").

I AGREE to release the Kelli Paulson Horsemanship, Trail Rider Challenge and the Competition from all claims for damages or otherwise for any Harm to me or my horse, and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of Kelli Paulson Horsemanship, Trail Rider Challenge or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Group or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Kelli Paulson Horsemanship, Trail Rider Challenge and the Competition and to hold them harmless with respect to claims for Harm to me, my horse, and or my child, and for claims made by others for any Harm caused by me or my horse at the Competition. I understand that I am entitled to wear protective equipment without penalty, and that my child is required to wear protective equipment.

If I am a parent or guardian of a junior exhibitor, I consent to my child's participation and AGREE to assume all of the obligations of this Release on behalf of my child.

I AGREE that Kelli Paulson Horsemanship, Trail Rider Challenge and "Competition" as used herein includes all of the officials, officers, directors, employees, agents, personnel, and volunteers of Kelli Paulson Horsemanship, Trail Rider Challenge and the Competition, as well as any affiliated organizations.

I AGREE that if I am injured at this Competition, the medical personnel treating my injuries may provide information on my injury and treatment to Kelli Paulson Horsemanship, Trail Rider Challenge.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

BY SIGNING BELOW, I AGREE to be bound by all applicable Trail Rider Challenge Rules and all terms and provisions of this entry and future entries.
